## **Contract Agreement**

MINDORO STATE COLLEGE OF AGRICULTURE AND TECHNOLOGY (MINSCAT) - MAIN CAMPUS, a public institution of higher learning, duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at Alcate, Victoria, Oriental Mindoro, represented by its College President, DR. JESSE T. ZAMORA hereinafter called the "Entity" of the one part and NEW CENTURY BOOKS AND GENERAL MERCHANDISE duly organized and existing under the laws of the Republic of the Philippines with office address at 4/f, Rm 400 Topaz Bldg., No. 101 Kamias Road, Brgy Pinyahan, Quezon City, represented by its Proprietor, MS. JONNALYN NAVA CABASAL, hereinafter called the "Supplier" of the other part;

WHEREAS, the Entity invited Bids for the **PROCUREMENT OF E-BOOKS FOR THE COLLEGE LIBRARY OF MINSCAT-MAIN CAMPUS** and has accepted a Bid by the Supplier for the supply of the good in the sum of **SIX HUNDRED FIVE THOUSAND NINE HUNDRED TWENTY ((Php 605,920.00) PESOS** hereinafter called "the Contract Price".

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Bid Form and the Price Schedule submitted by the Bidder;
  - (b) the Schedule of Requirements;
  - c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract; and
  - (f) the Entity's Notification of Award.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
