GIGA MANAGEMENT AND CATERING SERVICES, INC., with principal address at Aninuan, Puerto Galera, Oriental Mindoro, represented by CYNTHIA M. CRISOSTOMO, Manager, herein referred to as the 'Second Party'

## -Witnesseth-

- That the First Party is in need of the services of the Second Party for the venue, foods and accommodation of the visitors during the Meeting of Council of Presidents in Puerto Galera on January 14-15, 2020;
- 2. That the Second Party signified intention of providing venue, food and accommodation needed by the First Party for the above stated activity;
