WHEREAS, the Mindoro State College of Agriculture and Technology (MinSCAT), through Bids and Awards Committee (BAC) has advertised in the PhilGEPS and MinSCAT Website the Request for Quotation (RFQ) for the project "Supply and Delivery of Office Supplies for Printing of Instructional Materials in MinSCAT Main Campus" with an Approved Budget for the Contract (ABC) in the amount of Three Hundred Fifty-One Thousand Five Hundred Pesos (PhP 351,500.00);

WHEREAS, in response to the said advertisement, two (2) suppliers were found in the document request list and two (2) suppliers in the name of **GEORVI'S ENTERPRISES** and **NEW ISLAND ENTERPRISES** submitted price quotation for the said project before the deadline;

WHEREAS, the BAC examined and verified the price quotation submitted by the two (2) suppliers;

WHEREAS, only one (1) supplier in the name of **NEW ISLAND ENTERPRISES** was found to be complying and responsive;

WHEREAS, the other one (1) supplier in the name of **GEORVI'S ENTERPRISES** was disqualified to bid since the offered quotation exceeded that of the ABC.

NOW, THEREFORE, the members of Bids and Awards Committee (BAC) **HEREBY RESOLVE AS IT IS HEREBY RESOLVED** that the BAC recommends to the College President the approval of this resolution for the abovementioned procurement awarding of **Supply and Delivery of Office Supplies for Printing of Instructional Materials in MinSCAT Main Campus** to **NEW ISLAND ENTERPRISES** with official address at Filipiniana Complex, Nacoco, Calapan City, Oriental Mindoro as the bidder/supplier with Single Calculated Responsive Bid (SCRB), amounting to **Three Hundred Fifty-One Thousand Pesos (PhP 351,000.00)**.
