 This Contract of Service made and entered into this 14th day of December 2020 at Alcate, Victoria, Oriental Mindoro, Philippines by and between:

The **Mindoro State College of Agriculture and Technology (MinSCAT)**, a government educational institution of higher learning, with principal address at Alcate, Victoria, Oriental Mindoro, represented by the College President, **LEVY B. ARAGO, JR., Ph.D.**, hereinafter referred to as the 'First Party'

B SQUARE CONSTRUCTION AND SUPPLIES, represented by **MARC BRIAN R. GENETA**, Proprietor with principal address at Babangonan, Victoria, Oriental Mindoro, herein referred to as the 'Second Party'

-Witnesseth-

1. That the First Party is in need of the labor services of the Second Party for the project "**Labor for Construction of Covered Pathways and Fabrication of Guard Post in MinSCAT Main Campus**";
2. That the Second Party signified intention of providing the labor services for the above cited project;
3. That the Second Party is capacitated to provide the above cited services after it has been found complying and responsive to the services being required;
4. That the Second Party hereby attests of being not related within the third degree of consanguinity or affinity to the representative of the First Party; that he/she has not been previously dismissed from government service by reason of an administrative offense; and that he/she has not reached the compulsory retirement age of sixty-five (65);
5. That in view of hereof, the Second Party is contracted by the First Party to provide the labor services;
6. That the total contract price is **Two Hundred Four Thousand Five Hundred (PhP204,500.00)**. The First Party agreed to pay the Second Party in full, upon completion of the services; and

That it is understood that this Contract does not create an employer-employee relationship between the First Party and the Second Party; that the services rendered hereunder are not considered and will not be accredited as a government service; and that the latter is not entitled to benefits enjoyed by the regular personnel of the First Party.
