KNOW ALL MEN BY THESE PRESENTS:

THIS SERVICE AGREEMENT, made and entered into this 22 day of April, 2024 by and between:

The Mindoro State University (MinSU), a government educational institution of higher learning, with principal address at Alcate, Victoria, Oriental Mindoro, represented by CHRISTIAN ANTHONY C. AGUTAYA, Ph.D., OIC-Office of the University President, hereinafter referred to as the "First Party"

-and-

JRU ELECTRONICS & GENERAL MERCHANDISE, with principal address at Blk. 4, Sta. Maria village, Calapan City Oriental Mindoro represented by JAMES JEFFERSON R. UY, Proprietor, herein referred to as the "Second Party"

WITNESSETH

- 1. That the First Party is in need of the services for the "Rentals of Lights and Sounds for the MCC Days 2024 of MinSU Calapan City Campus";
- 2. That the Second Party signified intention of providing services needed by the First Party for the above stated activity;
- 3. That the Second Party is capacitated to provide the above cited services after it has been found complying and responsive to the services being required;
- 4. That the Second Party hereby attests of being not related within the third degree of consanguinity or affinity to the representative of the First Party;

- 6. That the total contract price is **Sixty-Five Thousand Pesos** (Php 65,000.00).
