This Contract of Service, made and entered into this 13th day of January 2021 in Alcate, Victoria, Oriental Mindoro, Philippines by and between:

The **Mindoro State College of Agriculture and Technology (MinSCAT)**, a government educational institution of higher learning, with principal address at Alcate, Victoria, Oriental Mindoro, represented by the College President, **LEVY B. ARAGO, JR., Ph.D.**, SUC President III, hereinafter referred to as the 'First Party'

-and-

MKA ENTERPRISES, with principal address at Calapan City, Oriental Mindoro, represented by **MA. MICHELLE K. ACEDERA**, Owner, herein referred to as the 'Second Party'

-Witnesseth-
