**WHEREAS**, the Mindoro State College of Agriculture and Technology (MinSCAT), through Bids and Awards Committee (BAC) has advertised in the PhilGEPS and MinSCAT Website and has posted in the conspicuous place in MinSCAT, the Invitation to Bid for the project “Rehabilitation of Water System for MinSCAT Forest Reserved in MinSCAT Main Campus” with an Approved Budget for the Contract (ABC) in the amount of **One Million Five Hundred Thousand Pesos (PhP 1,500,000.00)**;

**WHEREAS**, in response to the said advertisements, two (2) contractors found in the document request list, however, only one (1) contractor purchased and submitted the bidding documents;

**WHEREAS**, the only one (1) bid proposal was submitted on August 18, 2020 in the name of **TWENTY SIXTEEN CONSTRUCTION AND GENERAL MERCHANDISE**;

**WHEREAS**, the bid proposal submitted by the bidder who passed the preliminary evaluation of bid was found to be substantially complying;
