This Contract of Service made and entered into this 7th day of April, 2021 at Alcate, Victoria, Oriental Mindoro, Philippines by and between:

The **Mindoro State College of Agriculture and Technology (MinSCAT)**, a government educational institution of higher learning, with principal address at Alcate, Victoria, Oriental Mindoro, represented by the College President, **LEVY B. ARAGO, JR., Ph.D.**, College President, hereinafter referred to as the 'First Party'

-and-

HATULAN ENGINEERING WORKS AND MACHINE SHOP, represented by **FELIXBERTO E. HATULAN**, Service Provider with principal address at Sta. Isabel, Calapan City, Oriental Mindoro, as the 'Second Party'

-Witnesseth-

1. That the First Party is in need of the services of the Second Party for the project "**Materials and Labor for General Engine Overhaul of College Vehicle in MinSCAT Main Campus**";
2. That the Second Party signified intention of providing the services for the above cited project;
3. That the Second Party is capacitated to provide the materials and labor for general engine overhaul of college vehicle after he has been found complying and responsive to the services being required;
4.
