**WHEREAS**, the Mindoro State College of Agriculture and Technology through the Bids and Awards Committee (BAC) has advertised in the PhilGEPS and MinSCAT Websites and has posted in the conspicuous place in MinSCAT, the Invitation to Bid for the project "Supply and Delivery of Office Supplies for Various Offices in the Three Campuses of MinSCAT" with an Approved Budget for the Contract (ABC) in the amount of **One Million Four Hundred Sixty-Four Thousand Eight Hundred Twenty Pesos and 78/100 (Php 1,464,820.78)**;

**WHEREAS**, in response to the said advertisement, eight (8) suppliers were found in the document request list, however, only two (2) suppliers in the name of **HIRAMS' SUPPLY WHOLESALING** and **MARC JILL GENERAL MERCHANDISE** purchased and submitted the bidding documents;

**WHEREAS**, two (2) bid proposals in the name of **HIRAMS' SUPPLY WHOLESALING** and **MARC JILL GENERAL MERCHANDISE** were submitted on March 19, 2021;

**WHEREAS**, the bid proposals submitted by the bidders who passed the preliminary evaluation of bid were found to be substantially complying;


