**WHEREAS**, after careful examination, re-validation and re-verification of all the eligibility, technical and financial requirements submitted by the two (2) bidders for Lot 2, **FILCRAFTERS INC.** offered the Lowest bid but found non-complying while **LGC Design Option Office Furniture** the second bidder found complying;

**NOW, THEREFORE**, the members of Bids and Awards Committee (BAC) **HEREBY RESOLVED AS IT IS HEREBY RESOLVED** that the BAC recommend for the Approval by the Head of Procuring Entity of Mindoro State University the award of the project **“Supply and Delivery of Science, Technology, Fishery, Agriculture and Engineering Laboratory Furniture and Fixtures in MinSCAT Victoria, Calapan and Bongabong Campus to LGC Design Option Office Furniture** with official address 28-B Kalapati St. Villilia Village, Talipapa Novaliches, Quezon City as second Lowest Calculated Bid (LCRB) amounting **Three Million Two Hundred Forty Three Thousand Three Hundred Eleven Pesos (PhP 3,243,311.00)**
