This Contract of Service, made and entered into this 11th day of June 2021 at Alcate, Victoria, Oriental Mindoro, Philippines by and between:

ARAGO, JR., Ph.D.**, College President, hereinafter referred to as the 'First Party'

B. SQUARE CONSTRUCTION AND SUPPLIES, represented by

MARC BRIAN R. GENETA, Service Provider with principal address at Babangonan, Victoria, Oriental Mindoro, as the 'Second Party'

-Witnesseth-

1. That the First Party is in need of the services of the Second Party for the project "Construction of Plant Nursery at MinSCAT Victoria Campus";
2. That the Second Party signified intention of providing the services for the above cited project;
3. That the Second Party is capacitated to provide the services after having been found complying and responsive to the services being required;
4. That the Second Party hereby attests of being not related within the third degree of consanguinity or affinity to the representative of the First Party; that he has not been previously dismissed from government service by reason of an administrative offense; and that he has not reached the compulsory retirement age of sixty-five (65);
