**NOW, THEREFORE**, the members of Bids and Awards Committee (BAC) **HEREBY RESOLVE AS IT IS HEREBY RESOLVED** that the BAC recommends to the College President approval of this resolution for the abovementioned procurement awarding of “Construction of Plant Nursery in MinSCAT Victoria Campus” to **B.
