This Contract of Service made and entered into this 10th day of August 2021 at Alcate, Victoria, Oriental Mindoro, Philippines by and between:

JOVITO T. CADATAL SURVEYING OFFICE, represented by **JOVITO T. CADATAL**, Service Provider with principal address at Poblacion 3, Naujan, Oriental Mindoro, as the 'Second Party'

-Witnesseth-

1. That the **First Party** is in need of the services of the **Second Party** for the project "**Procurement of Geodetic Services for Relocation Survey of Land in MinSU Main Campus;**
