KNOW ALL MEN BY THESE PRESENTS:

This Contract of Service, made and entered into this 26th day of August 2021 at Alcate, Victoria, Oriental Mindoro, Philippines by and between:

The **Mindoro State University (MinSU)**, a government educational institution of higher learning, with principal address at Alcate, Victoria, Oriental Mindoro, represented by the University President, **LEVY B. ARAGO, JR., Ph.D.** hereinafter referred to as the 'First Party'

-and-

KDA LIGHT AND SOUND, represented by **JERWIN C. ABILAR**, Service Provider with principal address at Sta, Maria Village, Calapan City, Oriental Mindoro, as the 'Second Party'

-Witnesseth-

1. That the First Party is in need of the services of the Second Party for the project "**Lights, Sound and Social Media Live Services for Mindoro State University Inauguration Program**";
2. That the Second Party signified intention of providing the services for the above cited project;
3. That the Second Party is capacitated to provide the light and sound, LED Wall and Social Media Live Feed after he has been found complying and responsive to the services being required;
4. That the Second Party hereby attests of being not related within the third degree of consanguinity or affinity to the representative of the First Party; that he has not been previously dismissed from government service by reason of an administrative offense; and that he has not reached the compulsory retirement age of sixty-five (65);
5. That in view of hereof, the Second Party is contracted by the First Party to provide the video production services;
6. That the total contract price is One Hundred Twelve Thousand Pesos (Php 112,000.00) only. The First Party agreed to pay the Second Party in full, upon completion of the video production services; and

That it is understood that this Contract does not create an employer-employee relationship between the First Party and the Second Party; that the services rendered hereunder are not considered and will not be accredited as a government service; and that the latter is not entitled to benefits enjoyed by the regular personnel of the First Party.




