KNOW ALL MEN BY THESE PRESENTS:

This Contract of Service, made and entered into this 26<sup>th</sup> day of August 2021 in Alcate, Victoria, Oriental Mindoro, Philippines by and between:

The **Mindoro State University (MinSU)**, a government educational institution of higher learning, with principal address at Alcate, Victoria, Oriental Mindoro, represented by the University President, **LEVY B. ARAGO, JR., Ph.D.** hereinafter referred to as the 'First Party'

-and-


**WIGGINS RESTAURANT AND CATERING SERVICES**, with principal address at M.H. del Pilar St , Calapan City, Oriental Mindoro, represented by **LOUI GUY A. BELMONTE**, Manager, herein referred to as the 'Second Party'


-Witnesseth-

1. That the First Party is in need of the services of the Second Party for the foods of the visitors during the Inauguration, Oath Taking Ceremony, Investiture and Visitation of TES Grantees in Calapan City on August 27, 2021;
2. That the Second Party signified intention of providing accommodation needed by the First Party for the above stated activity;
3. That the Second Party is capacitated to provide the above cited services after it has been found complying and responsive to the services being required;
4. That the Second Party hereby attests of being not related within the third degree of consanguinity or affinity to the representative of the First Party; that he/she has not been previously dismissed from government service by reason of an administrative offense; and that he/she has not reached the compulsory retirement age of sixty-five (65);
5. That in view of hereof, the Second Party is contracted by the First Party to provide accommodation in the holding of inauguration, oath taking ceremony, investiture and visitation of TES grantees.
6. That the total contract price is One Hundred Thirty-Nine Thousand Two Hundred Pesos (PhP 139,200.00) only. The First Party agreed to pay the Second Party in full, upon completion of the services; and
7. That it is understood that this Contract does not create an employer-employee relationship between the First Party and the Second Party; that the services rendered hereunder are not considered and will not be accredited as a government service; and that the latter is not entitled to benefits enjoyed by the regular personnel of the First Party.


