RESUMPTION OF FREEDOM OF INFORMATION (FOI) REQUESTS PROCESSING IN THE ELECTRONIC FOI (eFOI) PORTAL

Dear FOI Receiving Officer and Decision Makers:

Greetings from the Presidential Communications Office (PCO)!

We are happy to inform you that the Electronic Freedom of Information (eFOI) portal (www.foi.gov.ph) is now back online after completing its recent upgrade and maintenance.

In this regard, lodging of FOI requests through the **Google Form link FOIREQUESTFORM** shall be terminated effective 31 July 2024. All requests received until 31 July 2024 through the Google Form link shall be processed accordingly, pursuant to PCO Memorandum Circular No. 24-002.

Effective immediately, all eFOI requests shall be processed through the respective agency dashboards via **FOI CMS**. These enhancements are designed to streamline the workflow and improve the overall efficiency of handling public information requests.

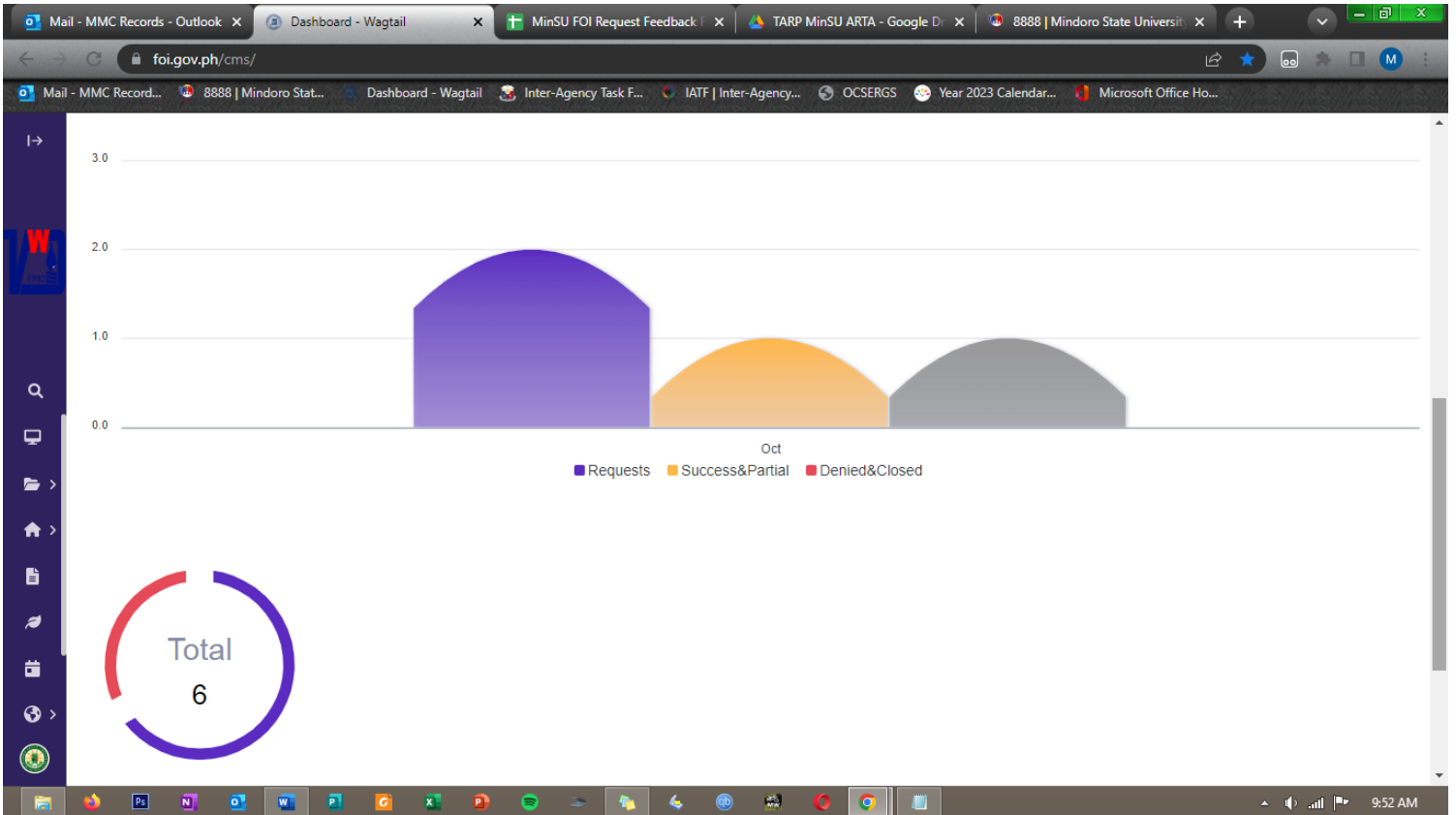
Kindly log in to your agency dashboard to access and review all eFOI requests received through the portal.
