**WHEREAS**, in response to the said invitation and advertisement, two (2) suppliers/bidders in the name of **IRAYA LIFE ENTERPRISES** and **ARJELON ENTERPRISES AND TRADING CORPORATION** submitted price quotation before the deadline;

**WHEREAS**, upon the initial assessment of the price quotation submitted by **ARJELON ENTERPRISES AND TRADING CORPORATION**, it was determined that the items specified under RFQ 2025-151 are not covered under the supplier's declared line of business as indicated in their BIR Certificate of Registration (Form 2303).

**WHEREAS**, as a result of the non-compliance with the mandatory eligibility requirement, a detailed assessment of the submitted quotation concluded with the disqualification of **ARJELON ENTERPRISES AND TRADING CORPORATION** from further consideration;

**WHEREAS**, the detailed evaluation of price quotation resulted in the following:
