Resolution No. 150, s. 2023

WHEREAS, the Mindoro State University (MinSU), through Bids and Awards Committee (BAC) has advertised in the PhilGEPS and MinSU Website the Request for Quotation (RFQ) for the project "**Supply and Delivery of Drugs and Medicines for the University Clinic at MinSU Main Campus**" with an Approved Budget for the Contract (ABC) in the amount of **Three Hundred Thirty-seven Thousand Six Hundred Fifteen Pesos and 01/100 (Php 337,615.01)**;

WHEREAS, in response to the said advertisement, three (3) suppliers were found in the document request list and three (3) suppliers in the name of **LUNARMED PHARMA TRADING, CPA PHARMACY,** and **NASAKIAH TRADING** submitted price quotation before the deadline;

WHEREAS, the detailed evaluation of price quotation resulted in the following:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidders, **CPA PHARMACY** and **NASAKIAH TRADING** passed the evaluation of bid and were found to be complying and responsive; however, the price quotation submitted by **LUNARMED PHARMA TRADING** was found to be unresponsive and uncompliant due to the following reasons:

1. The supplier submitted incomplete documents and;
2. The supplier cannot supply the items listed below due to unavailability;
 - Calamine lotion 60ml
 - Clobetasole cream 15mg
 - Dextromethopan HBr 5mg lozenges (dry cough) by 6's
 - Dextromethopan HBR 15mg/5ml syrup 54ml
 - Hypromellose 15ml eye drops
 - Ipratropium Bromide 500mcg 2.5ml
 - Mefenamic Acid 500mg tablets by 100's
 - Neomycin SO4 PolymycinB SO4 Dexamethasone drops
 - Neomycin SO4 PolymycinB SO4 Dexamethasone ointment
 - Povidone Iodine Oral Gargle 1% Antiseptic 120ml
 - Salbutamol 100mcg/ dose 200 actuations metered dose inhaler
 - Tetanus Toxoid absorbed 40iu/ml
 - Terbutaline Sulfate 5mg

WHEREAS, the BAC declared **CPA PHARMACY** as the supplier with the Lowest Calculated Responsive Bid (LCRB) for the reason that the first supplier in ranking was disqualified;

NOW, THEREFORE, the members of Bids and Awards Committee (BAC) **HEREBY RESOLVED AS IT IS HEREBY RESOLVED** recommended to the Head of Procuring Entity the approval of this resolution for the abovementioned procurement and awarding of contract for the "**Supply and Delivery of Drugs and Medicines for the University Clinic at MinSU Main Campus**" to **CPA Pharmacy** in the amount **Two Hundred Fifty Thousand Two Hundred Ninety Pesos (Php 250,290.00)** with official address at Poblacion I, Victoria, Oriental Mindoro as the supplier/bidder with the **Lowest Calculated Responsive Bid (LCRB)**;


