DECLARING FAILURE OF REQUEST FOR QUOTATION AND RECOMMENDING NEGOTIATED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF OTHER SUPPLIES, OFFICE EQUIPMENT, FURNITURE & FIXTURES AND OUTDOOR EQUIPMENT FOR THE PBO OFFICE AT MINSU CALAPAN CITY CAMPUS

WHEREAS, the Mindoro State University (MinSU), through Bids and Awards Committee (BAC) has advertised in the PhilGEPS and MinSU Website the Request for Quotation (RFQ) for the project "Supply and Delivery of Other Supplies, Office Supplies, Office Equipment, Furniture & Fixtures and Outdoor Equipment for the PBO Office at MinSU Calapan City Campus" with an Approved Budget for the Contract (ABC) amounting to One Hundred Ten Thousand Three Hundred Thirty-Six Pesos (Php 110,336.00);

WHEREAS, in response to the first publication of the project on September 25, 2023; four (4) suppliers were found in the document request list however, no supplier submitted the Request for Quotation (RFQ) thus, declared failure of RFQ:
