WHEREAS, the Mindoro State University (MinSU), through Bids and Awards Committee (BAC) has advertised in the PhilGEPS and MinSU Website the Request for Quotation (RFQ) for the project "Supply and Delivery of Uniforms for the CCAA 2023 Delegates of MinSU Calapan City Campus" with an Approved Budget for the Contract (ABC) amounting to **One Hundred Twenty Thousand Four Hundred Fifty-One Pesos (Php120,451.00)**;

WHEREAS, in response to the said advertisement, three (3) suppliers were found in the document request list however, four (4) suppliers in the name of **SEAWEED INTERNATIONAL EXPORTS INCORPORATED, VILMA ROLDAN RTW STORE, GEORVI'S ENTERPRISES** and **GUHIT ARTS CENTER & SPORTING GOODS** submitted price quotation before the deadline;

WHEREAS, the detailed evaluation of price quotation resulted in the following:


WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidders, **VILMA ROLDAN RTW STORE, GEORVI'S ENTERPRISES** and **GUHIT ARTS CENTER & SPORTING GOODS** passed the evaluation of bid and were found to be complying and responsive; however, the price quotation submitted by of **SEAWEED INTERNATIONAL EXPORTS INCORPORATED** was found to be unresponsive and uncompliant due to the following reasons:


- The supplier submitted incomplete documents specifically the following:
 - Latest Income Tax Return (Latest ITR);
- The item for Request for Quotation is not within their Line of Business as indicated in BIR for 2303 and;
- The supplier cannot supply the item no. 14-24 listed in the RFQ form;


WHEREAS, the BAC declared **VILMA ROLDAN RTW STORE** as the supplier with the Lowest Calculated Responsive Bid (LCRB) for the reason that the first supplier in ranking was disqualified;

NOW, THEREFORE, the Bids and Awards Committee (BAC) **HEREBY RESOLVED AS IT IS HEREBY RESOLVED**, recommended to the Head of Procuring Entity the approval of this resolution for the abovementioned procurement awarding of contract for the "Supply and Delivery of Uniforms for the CCAA 2023 Delegates of MinSU Calapan City Campus" to **Vilma Roldan RTW Store** amounting to **One Hundred Twenty Thousand Four Hundred Fifty-One Pesos (Php120,451.00)** with official address at Public Market, Calapan City, Oriental Mindoro as the supplier/bidder with the Lowest Calculated Responsive Bid (LCRB);
