WHEREAS, the Mindoro State University (Minsu), through the Bids and Awards Committee (BAC) has advertised in the PhilGEPS and Minsu Website the Request for Quotation (RFQ) for the project "Supply and Delivery of Agricultural Supplies for the STCAID Project of Minsu Main Campus" with an Approved Budget for the Contract (ABC) amounting to Six Hundred Thirteen Thousand One Hundred Forty Pesos (Php613,140.00) composed of 3 lots namely;

WHEREAS, in response to the said advertisement, three (3) suppliers were found in the document request list, and four (4) suppliers in the name of UNTALAN GENERAL MERCHANDISE AND AGRI SUPPLY, RAMGO INTERNATIONAL CORPORATION, HALCON GENERAL MERCHANDISE and ORTEGA CONSTRUCTION SUPPLY submitted price quotation before the deadline;

WHEREAS, UNTALAN GENERAL MERCHANDISE AND AGRI SUPPLY submitted price quotation for Lots 1, 2 and 3, RAMGO INTERNATIONAL CORPORATION for Lots 1 and 2, HALCON GENERAL MERCHANDISE for Lots 1, 2 and 3, and ORTEGA CONSTRUCTION SUPPLY for Lots 2 and 3;

WHEREAS, the detailed evaluation of price quotation resulted in the following:

WHEREAS, the BAC examined and verified the price quotations submitted by the abovementioned suppliers and was found to be complying and responsive; thus, the project shall be awarded to the supplier in the name of **UNTALAN GENERAL MERCHANDISE AND AGRI SUPPLY** with Lowest Calculated Responsive Bid (LCRB);

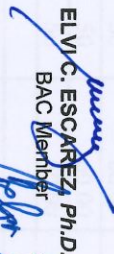

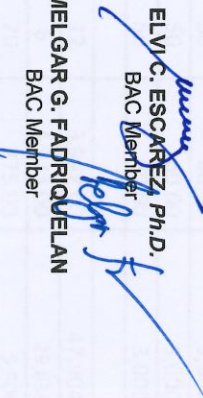
