Methodology

4. **Community Engagement:** Strengthens the university's reputation as a welcoming and forward-thinking institution, benefiting both internal and external stakeholders.

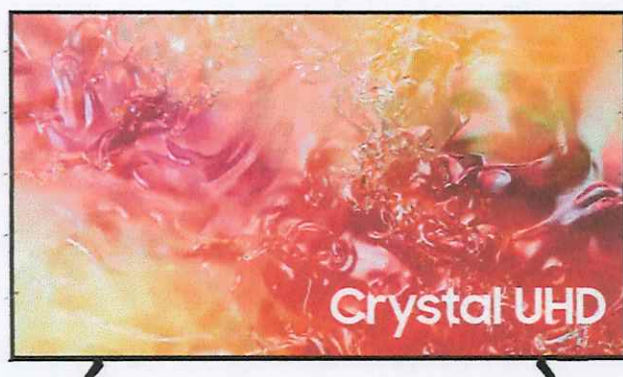

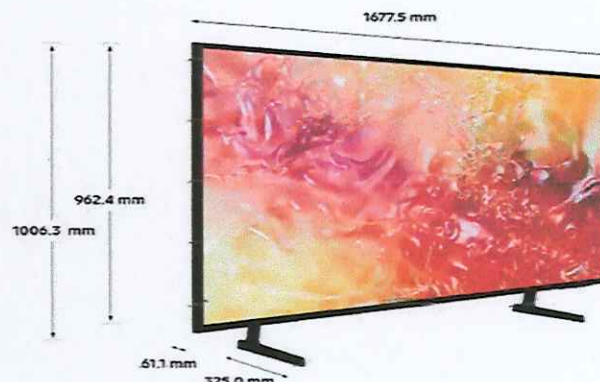
