WHEREAS, the Mindoro State University (MinSU), through Bids and Awards Committee (BAC) has advertised in the PhilGEPS and MinSU Website the Request for Quotation (RFQ) No. 2025-068 for the project "Supply and Delivery of Other Supplies and Materials for the University Library of MinSU Bongabong Campus" with an Approved Budget for the Contract (ABC) amounting to One Hundred Four Thousand Six Hundred Fifty Pesos (Php104,650.00);

WHEREAS, in response to the advertisement of the project, four (4) suppliers/bidders were found in the document request list, however five (5) suppliers/bidders in the name IRAYA LIFE ENTERPRISES, PAPERCAT OFFICE SUPPLIES AND EQUIPMENT TRADING, THIRD DEGREE PHARMA AND MEDICAL SUPPLIES TRADING, OSIVA ELECTRICAL SERVICES and ALGERANZ VARIETY SHOP submitted price quotation before the deadline;

WHEREAS, the submitted price quotations of name IRAYA LIFE ENTERPRISES, PAPERCAT OFFICE SUPPLIES AND EQUIPMENT TRADING and THIRD DEGREE PHARMA AND MEDICAL SUPPLIES TRADING passed the evaluation of technical eligibility requirements for the project;

WHEREAS, upon initial evaluation of the price quotations submitted by OSIVA ELECTRICAL SERVICES and ALGERANZ VARIETY SHOP, it was found that the eligibility documents were incomplete, specifically lacking the following mandatory requirements:

1. Latest Income Tax Return (ITR); and
2. Tax Clearance Certificate;

WHEREAS, due to the absence of the aforementioned documents, a detailed evaluation of the submitted price quotation led to the disqualification of OSIVA ELECTRICAL SERVICES and ALGERANZ VARIETY SHOP from further consideration;
