WHEREAS, during the preliminary evaluation of the price quotation submitted by PLAYMAKER SPORTS INC., it was determined that the file containing the eligibility requirements, submitted via email, was either corrupted or otherwise inaccessible upon opening;

WHEREAS, due to the inaccessibility of the eligibility documents, a detailed review of the submission was conducted, which ultimately resulted in the disqualification of PLAYMAKER SPORTS INC. from further consideration;
