WHEREAS, the Mindoro State University (Minsu), through Bids and Awards Committee (BAC) has advertised in the PhilGEPS and Minsu Website the Request for Quotation (RFQ) No. 2025-093 for the project "Supply and Delivery of Office Equipment for Instructional Purposes of Minsu Main Campus" with an Approved Budget for the Contract (ABC) amounting to One Hundred Ninety-Nine Thousand Eighty Pesos (Php199,980.00);

WHEREAS, in response to the advertisement of the project, four (4) suppliers/bidders were found in the document request list, however four (4) suppliers/bidders in the name KRISTWIN CONSUMER GOOD TRADING, IRAYA LIFE ENTERPRISES, LB2 LABORATORY SUPPLIES, and PAPERCAT OFFICE SUPPLIES AND EQUIPMENT TRADING submitted price quotations before the deadline;

WHEREAS, the submitted price quotations of KRISTWIN CONSUMER GOOD TRADING, IRAYA LIFE ENTERPRISES and PAPERCAT OFFICE SUPPLIES AND EQUIPMENT TRADING passed the evaluation of technical eligibility requirements for the project;

WHEREAS, during the preliminary evaluation of the price quotation submitted by LB2 LABORATORY SUPPLIES, it was determined that the file containing the eligibility requirements, submitted via email, was either corrupted or otherwise inaccessible upon opening;

WHEREAS, due to the inaccessibility of the eligibility documents, a detailed review of the submission was conducted, which ultimately resulted in the disqualification of LB2 LABORATORY SUPPLIES from further consideration;

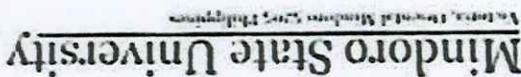
