THIS SERVICE AGREEMENT, made and entered into this **18th** day of **April 2022** by and between:

The **Mindoro State University (MinSU)**, a government educational institution of higher learning, with principal address at Alcate, Victoria, Oriental Mindoro, represented by **LEVY B. ARAGO, JR., Ph.D.**, University President, hereinafter referred to as the “**First Party**”

CONCEPT AND INFORMATION GROUP, INC., with principal address at 3450 Florida St., Palanan Makati City represented by **MS. GERALDINE C. DATOY**, Representative, herein referred to as the “**Second Party**”

W I T N E S S E T H

1. That the First Party is in need of the services for the project “**Publication of the Implementing Rules and Regulation of RA 10596 in Newspapers of General Circulation in the Philippines**”;

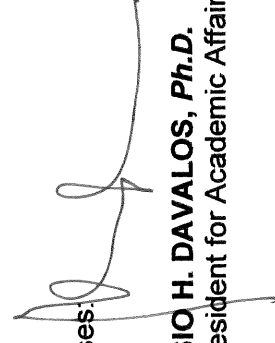

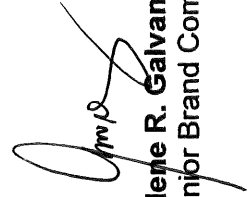
