-and-

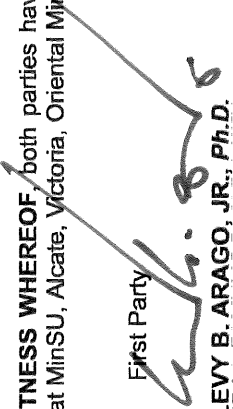

WITNESSETH

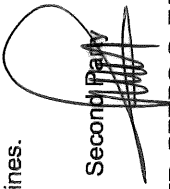

6. That the total contract price is **One Hundred Five Thousand Pesos (Php 105,000.00)**.
