THIS SERVICE AGREEMENT, made and entered into this 06 JUL day of 2022,

The **Mindoro State University (MinSU)**, a government educational institution of higher learning, with principal address at Alcate, Victoria, Oriental Mindoro, represented by **LEVY B. ARAGO, JR., Ph.D.**, University President, hereinafter referred to as the “**First Party**”

THE ZHUJAR MANUFACTURING CORPORATION, with principal address at #61 Kaingin Road Brgy. Apolonio Samson Quezon City represented by **MR. GURCHARAN SINGH**, Representative, herein referred to as the “**Second Party**”

WITNESSETH

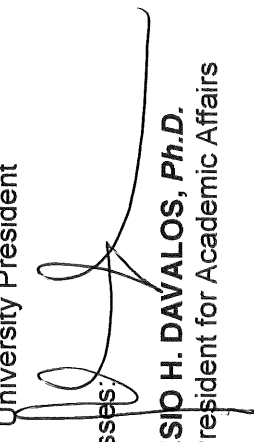

6. That the total contract price is **Sixty Four Thousand Eight Hundred Pesos (Php64,800.00)**.
