WITNESSETH

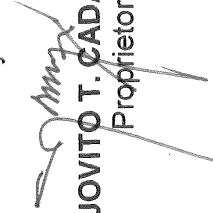
1. That the First Party is in need of the services for the project **"Labor for Geodetic Services for the Ground Relocation Survey of Three (3) Campuses of MinSU"**;

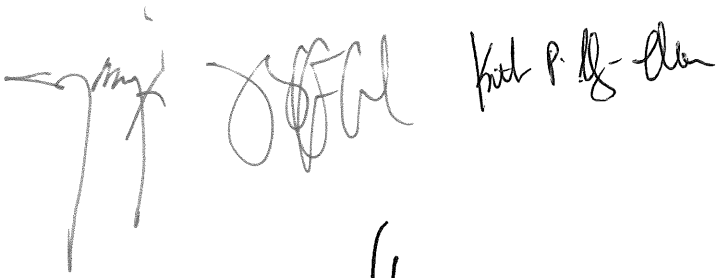
