THIS SERVICE AGREEMENT, made and entered into this 24 day of APRIL, 2025 by and between:

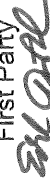

APOSTOL, Ph.D.**, herein referred to as the “**First Party**”;

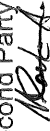

WITNESSETH:

1. That the First Party is in need of the services for the “**Supply, Delivery and Labor for Printing of TOR and Diploma for A.Y. 2024-2025 Graduation**”;

3. That the Second Party is capacitated to provide the above cited services after it has been found complying and responsive to the services being required;
4. That the Second Party hereby attests of being not related within the third degree of consanguinity or affinity to the representative of the First Party;
5. That in view of hereof, the Second Party is contracted by the First Party to provide services for “**Supply, Delivery and Labor for Printing of TOR and Diploma for A.Y. 2024-2025 Graduation**”;
6. That the total contract price is **Fifty-Five Thousand Pesos (Php55,000.00)**;
7. That the First Party agreed to pay the Second Party in full, upon completion of the Services for “**Supply, Delivery and Labor for Printing of TOR and Diploma for A.Y. 2024-2025 Graduation**” subject to the applicable budget and accounting procedures;
8. That the services shall be completed within **fifteen (15) working days**;
9. That the amount of one-tenth (1/10) of one percent (1%) of the contract amount per day for liquidated damages is hereby declared and understood to include all losses and cost of whatever nature the Government will sustain because of the failure of the Second Party to complete the contract within the stipulated time;
10. This Agreement shall include all such items, although not specifically mentioned, that can be reasonably inferred as being required for its completion as if such items were expressly mentioned herein. All the provisions of RA No. 9184 and its 2016 revised IRR, including the Generic Procurement Manual, and associated issuances, constitute the primary source for the terms and conditions of the Agreement, and thus, applicable in implementation. This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of RA No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.
