



Contract Agreement

KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT AGREEMENT made and entered this 16th day of January, 2020 between MINDORO STATE COLLEGE OF AGRICULTURE AND TECHNOLOGY (MinSCAT) a public institution of higher learning, duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at Alcate, Victoria, Oriental Mindoro, represented by its College President, DR. LEVY B. ARAGO, JR. hereinafter called the "Entity" of the one part, and TOYOTA BATANGAS CITY, INC. duly organized and existing under the laws of the Republic of the Philippines with office address at Diversion Road, Balagtas, Batangas City represented by its general manager, BRENDA V. RAULE hereinafter called the "Supplier" of the other part.

WHEREAS, the Entity invited Bids for the SUPPLY AND DELIVERY OF MOTOR VEHICLES IN MinSCAT and has accepted a Bid for the supply and delivery of said motor vehicles in the amount of FIVE MILLION THREE HUNDRED EIGHTY-THREE THOUSAND PESOS (Php 5,383,000.00) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and read and construed as part of this Agreement, viz:
 - a. the Bid Form and the Price Schedule submitted by the Bidder;
 - b. the Schedule Requirements;
 - c. the Technical Specifications;
 - d. the General Conditions of the Contract;
 - e. the Special Conditions of the Contract;
 - f. the Performance Security; and
 - g. the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects of the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects herein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




