**WHEREAS, GEORVI'S ENTERPRISES** and **NEW ISLAND ENTERPRISES** submitted price quotation for Lot 1 Office Supplies and Lot 3 Semi-Expendable of the said project;

**WHEREAS, GEORVI'S ENTERPRISES** and **NEW ISLAND ENTERPRISES** submitted incomplete price quotation for Lot 2 Fixtures of the said project;

**WHEREAS, BETH REYES MARKETING** submitted price quotation for Lot 2 Fixtures and Lot 3 Semi-Expendable of the said project;

**WHEREAS**, the BAC examined and verified the price quotation submitted by **GEORVI'S ENTERPRISES** and **NEW ISLAND ENTERPRISES** for Lot 1 Office Supplies and Lot 3 Semi-Expendable, **BETH REYES MARKETING** for Lot 2 Fixtures and Lot 3 Semi-Expendable and were found to be complying and responsive;

**WHEREAS, GEORVI'S ENTERPRISES** and **NEW ISLAND ENTERPRISES** disqualified to bid for Lot 2 Fixtures due to incomplete price quotation;

**WHEREAS**, of the two (2) suppliers, **GEORVI'S ENTERPRISES** offered the lowest price quotation for Lot 1 Office Supplies which is advantageous to the government;

**WHEREAS**, among the three (3) suppliers, **BETH REYES MARKETING** offered the lowest price quotation for Lot 3 Semi-Expendable which is advantageous to the government;
